General Safety Instructions

- Only connect the charging pad to power adapters that do not exceed 9V/2A (18 Watts)
- Be sure to unplug the charging pad from its power source when charging has completed
- Do not place the charging pad near heat sources or open flames
- Do not place metal objects on top of a phone that is currently charging on the magnetic charging pad
- Avoid using the charging pad in temperatures exceeding the maximum recommended operating temperature of 104°F (40°C) (see **Specifications Table** for details)
- Do not place the charging pad near water sources or attempt to operate it after being exposed to water
- Do not expose the charging pad to corrosive cleaning substances
- Do not attempt to use the charging pad if the charging cable is damaged, or with a damaged power adapter

Operation

1. Using the included USB-A to USB-C charging cable, connect the charging pad's USB-C connector to a USB-A power adapter, such as Tripp Lite's U280-W01-QC3-1 (sold separately).

OR

Connect the charging pad's USB-C connector to an available USB-A port on a laptop or computer that is being powered by an external power source.

2. Place a magnetic-charging compatible smartphone on the charging pad. Be sure to follow all recommended safety tips (see **General Safety Instructions**).
3. Remove the charging pad from its power source after charging your device.
